CHALLENGES SPECIFIC TO THE PROCESSING OF MADRID FILES

- **Subsequent designations, partial assignments were not processed in the original version of IPAS**
- **Late transmission of notifications due to server problem**
- **Madrid client became obsolete**

WHAT DID WE DO

- **Manually created files for the subsequent designations, partial assignments (IPAS old version)**
- **Close coordination with IB to resolve the irregularities, issues**
- **Transmit the notices thru Madrid Office Portal (MOP) with a covering letter and manually tag the notices as Manually transmitted to IB.**
- **Training Workshop for National IP offices for the XML data exchange on July 27 and 28, 2022.**
- **Meeting with Madrid Team 3 and WIPO IT officers to discuss data exchange**
- **Madrid-related processes (PRP, GP) were revised to “match” with the xml schema**

CURRENT ISSUES

- **Issuance of Grants of Protection (SOME goods and services-XML formatting)**
- **No enough IT manpower to focus on Madrid issues**

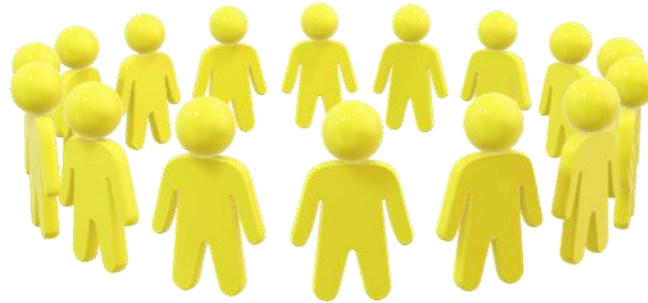

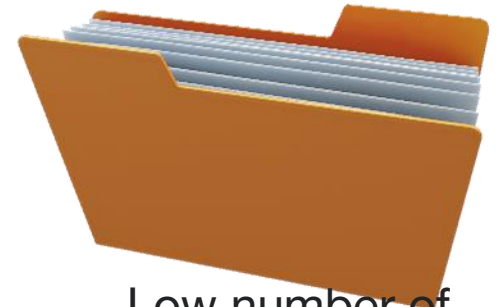


Number of owners who will use the system

PCT APPLICATIONS



-BEFORE the implementation of the mandatory online filing, PCT personnel manually encode the PCT application data, Priority Data, Applicant's address, Inventor's name and address, IPC

AFTER the implementation of the mandatory online filing:
--the filer needs to manually enter all information like the PCT application data, priority data, name and address of applicant and inventors. It is better to migrate or capture the data from WIPO Patentscope using the PCT application number. IPC from the International Application Status Report or WO Publication is being manually captured by the personnel from the PCT Unit.

PCT APPLICATIONS



- Categorization of application based on captured IPC is done manually to determine to which specific division or field it will be assigned for examination. Mistakes of manual categorization are sometimes encountered.



- Validation of correct format of PCT application number and International Publication number is missing in IPAS, thus, there is incorrect formatting of number
