 - 1-download,
 - 2-upload and
 - 3-process weekly on every Thursday.
- There is a utilities to upload the un-success upload pdf by using Madrid Module, so DIP frequently run that utility to make sure all the incoming notifications come with PDF.

2. MF3B Partial Provisional Refusal of Protection (Rule 17(1))
3. MF4 Statement of Total Grant of Protection (Rule 18ter(1))
4. MF5 Statement of Total or Partial Grant of Protection Following a Provisional Refusal (Rule 18ter(2))
5. MF6 Confirmation of Total Provisional Refusal (Rule 18ter(3))

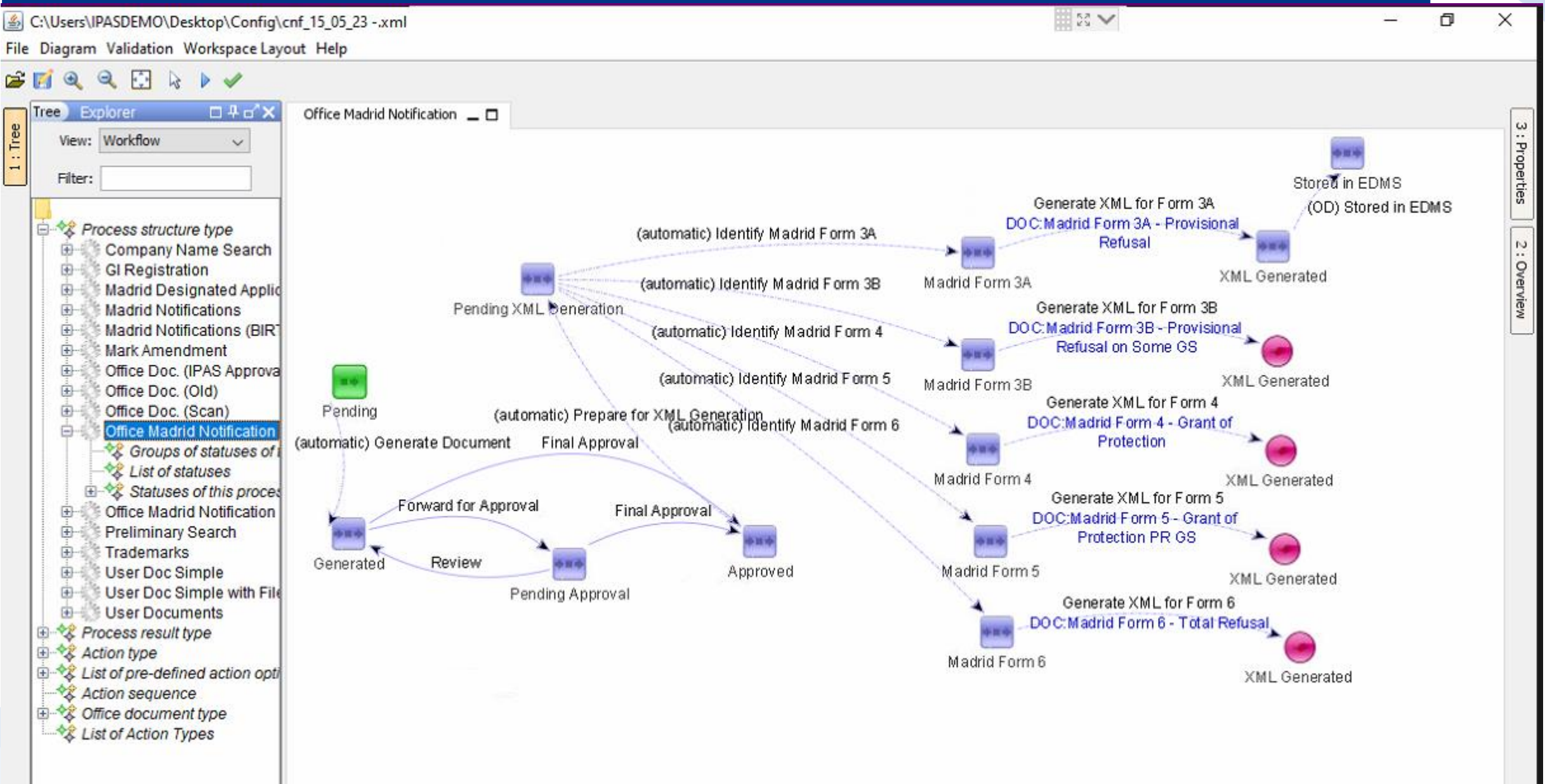

- Create new office workflow to support this feature (WIPO will provide)
- Private FTP to send to IB (WIPO will provide)
- Prepare the Word template to make its contents same as XML template
- Testing every forms which and sending to IB for checking before deploy in Production

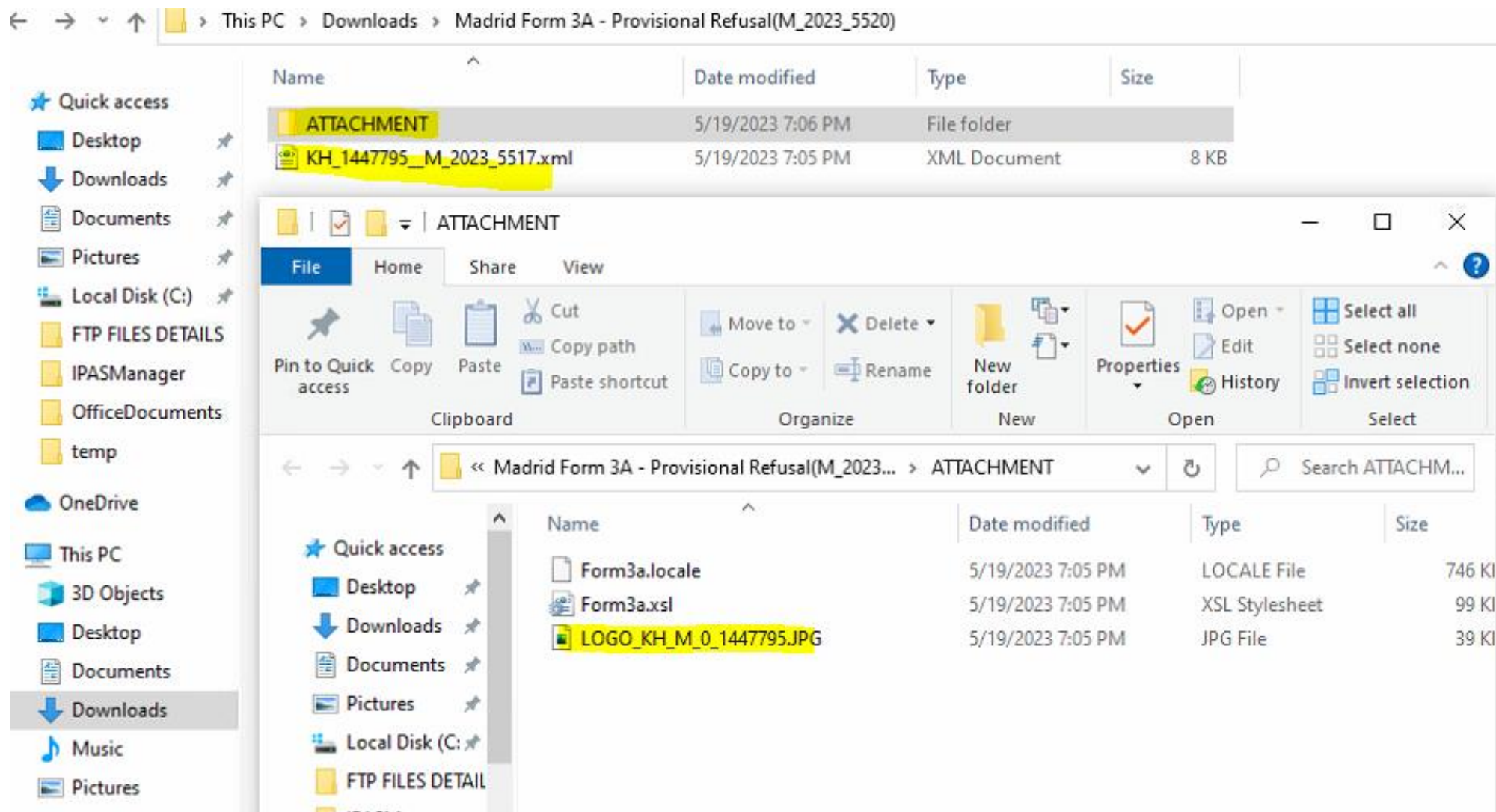

Information relating to the subsequent procedure:	<p>The applicant must respond in writing to this provisional refusal within sixty (60) days from receipt of the notification of this refusal from the International Bureau (IB). The response must be filed by a duly authorized resident representative in Cambodia. The representative must be appointed pursuant to Article 58 of the Law Concerning Marks, Trade Names and Acts of Unfair Competition and Article 28 of the Sub-Decree on the Implementation of the TM Law.</p> <p>Pursuant to Article 17(2) of the Sub-Decree on the Implementation of the Trademark Law, the applicant or holder, through the duly authorized representative, must submit the legal arguments, the required amendments or modifications, disclaimers (on any element(s) of the mark) or limitations required within the prescribed period.</p> <p>In the alternative and in accordance with Article 17(3) of the Sub-Decree on the Implementation of the Trademark Law, the holder, through the duly authorized representative, may submit a written request for a hearing to the Registrar. Upon receiving this request, the Registrar shall notify the applicant, in writing, at least one month before the date on which the applicant will be invited to be heard.</p> <p>Failure to respond to the provisional refusal within the required period will result in the abandonment of the international registration.</p> <p>If, after the holder's written response or hearing, the Registrar accepts the mark according to Article 19(1), the mark will be registered and the statement of grant of protection will be issued. The registered mark will then be published for opposition for a period of 90 days.</p> <p>However, if after considering the applicant's response or hearing, the Registrar still refuses the registration of the mark, the applicant may, pursuant to Article 18(1), within one (1) month from the date of the communication from the Registrar, request the confirmation of the decision and the materials referred to in the decision. 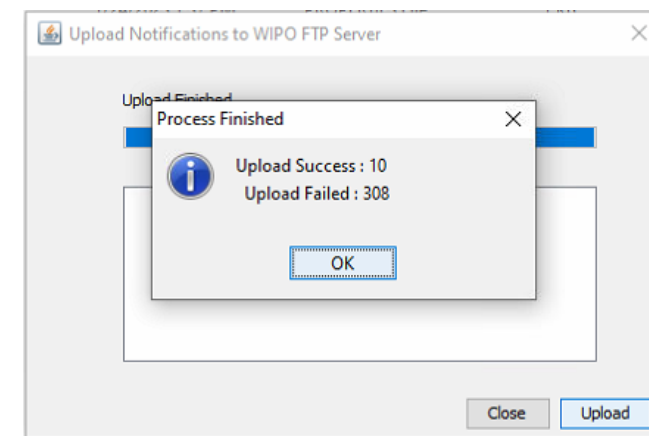

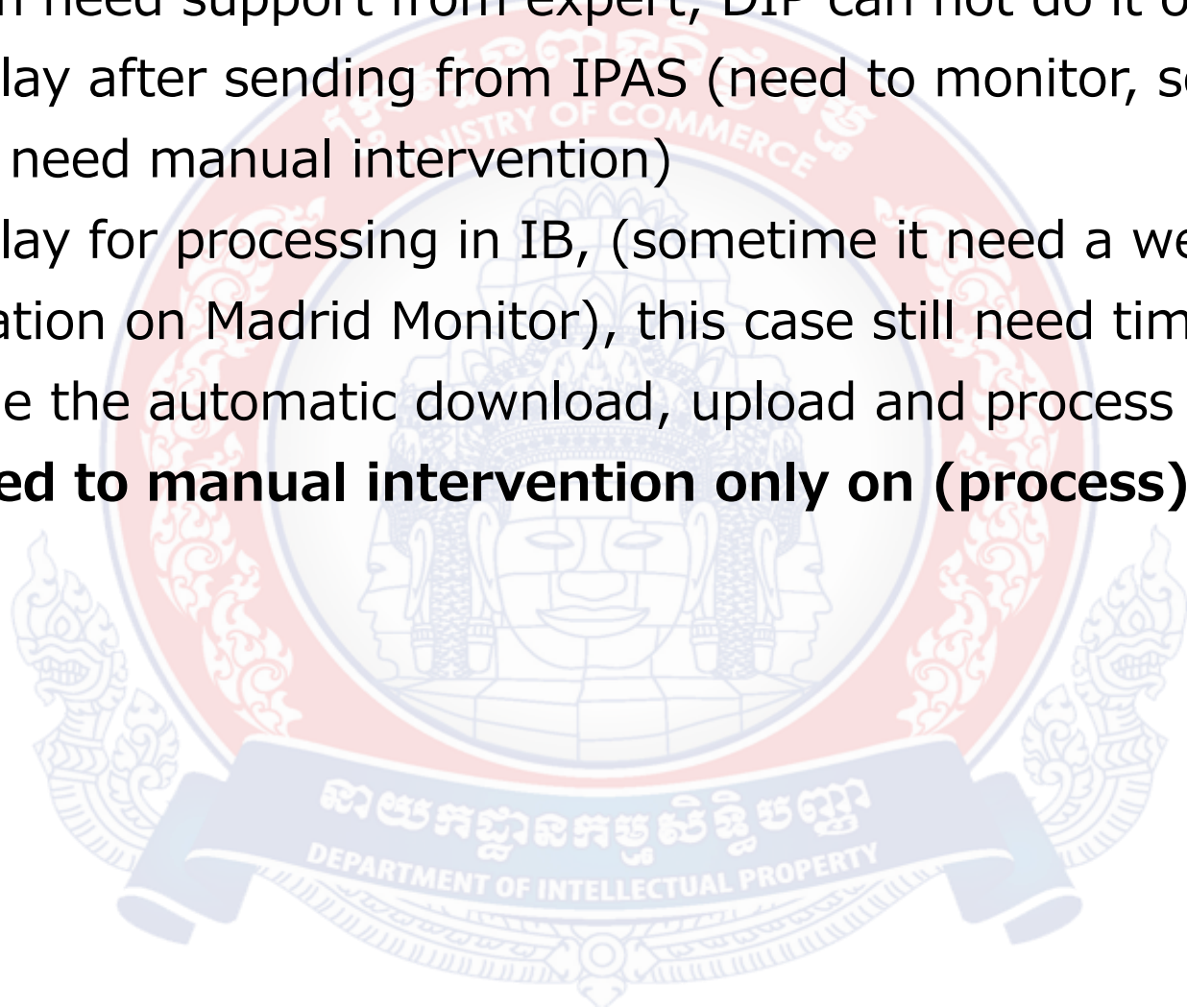

- Some delay after sending from IPAS (need to monitor, some case stuck need manual intervention)
- Some delay for processing in IB, (sometime it need a week, to see the notification on Madrid Monitor), this case still need time to investigate.
- Sometime the automatic download, upload and process is not work working, so **DIP need to manual intervention only on (process) step.**
