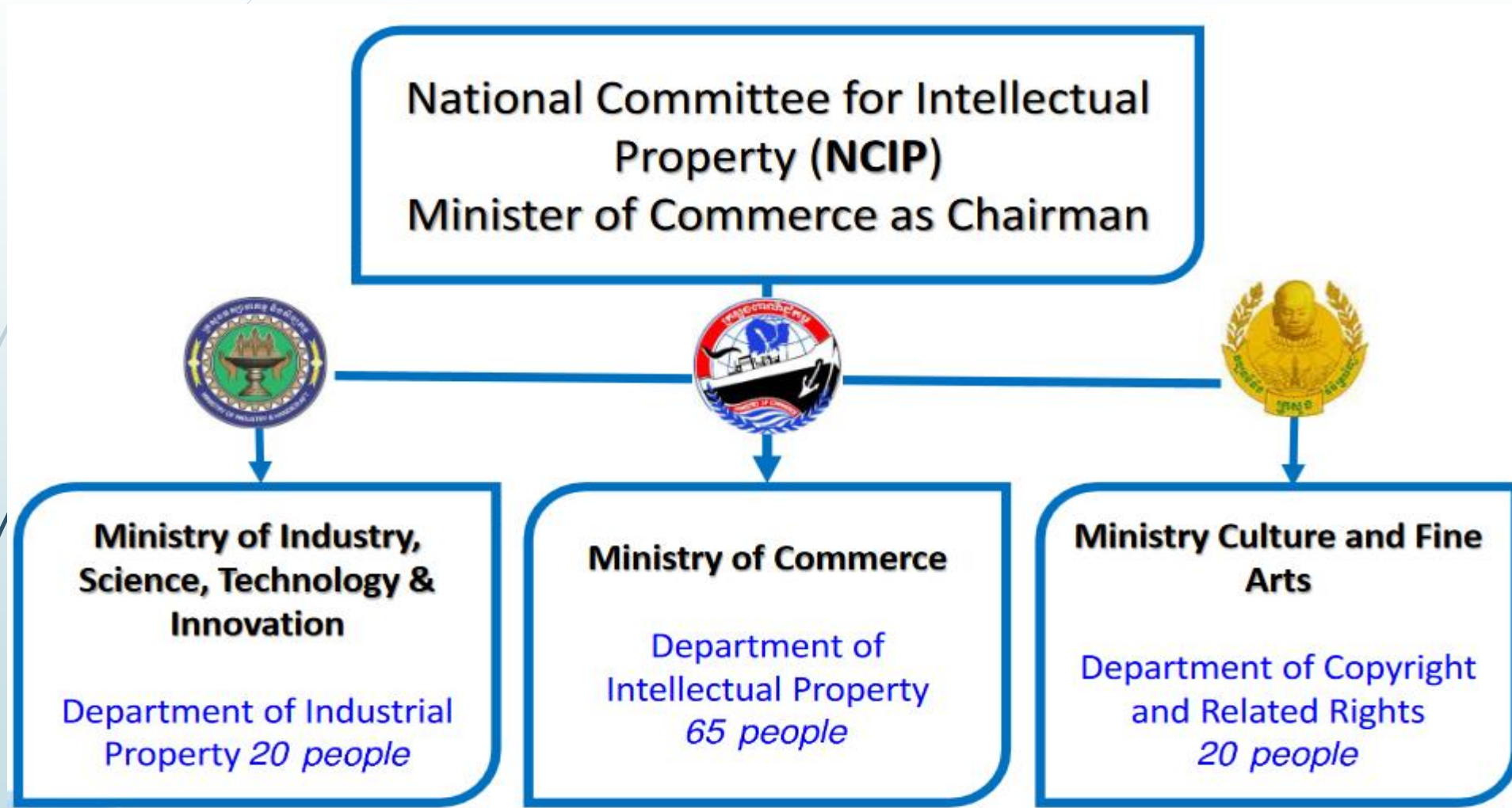

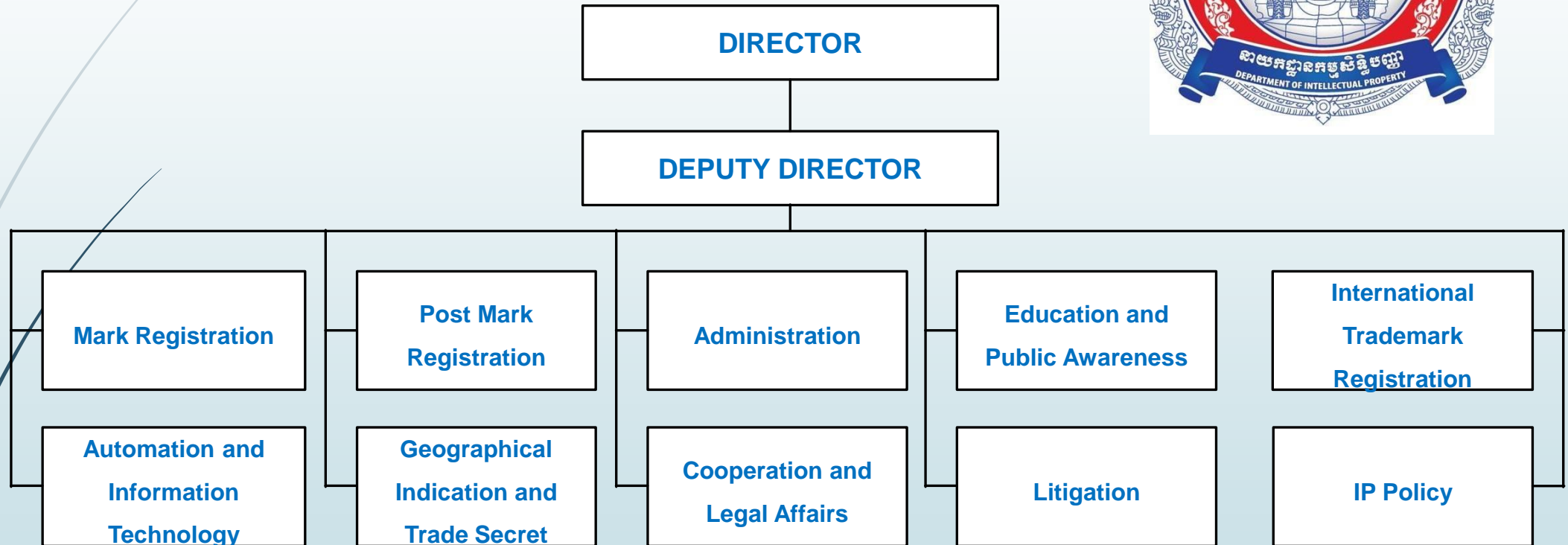


Organization chart of department of intellectual property

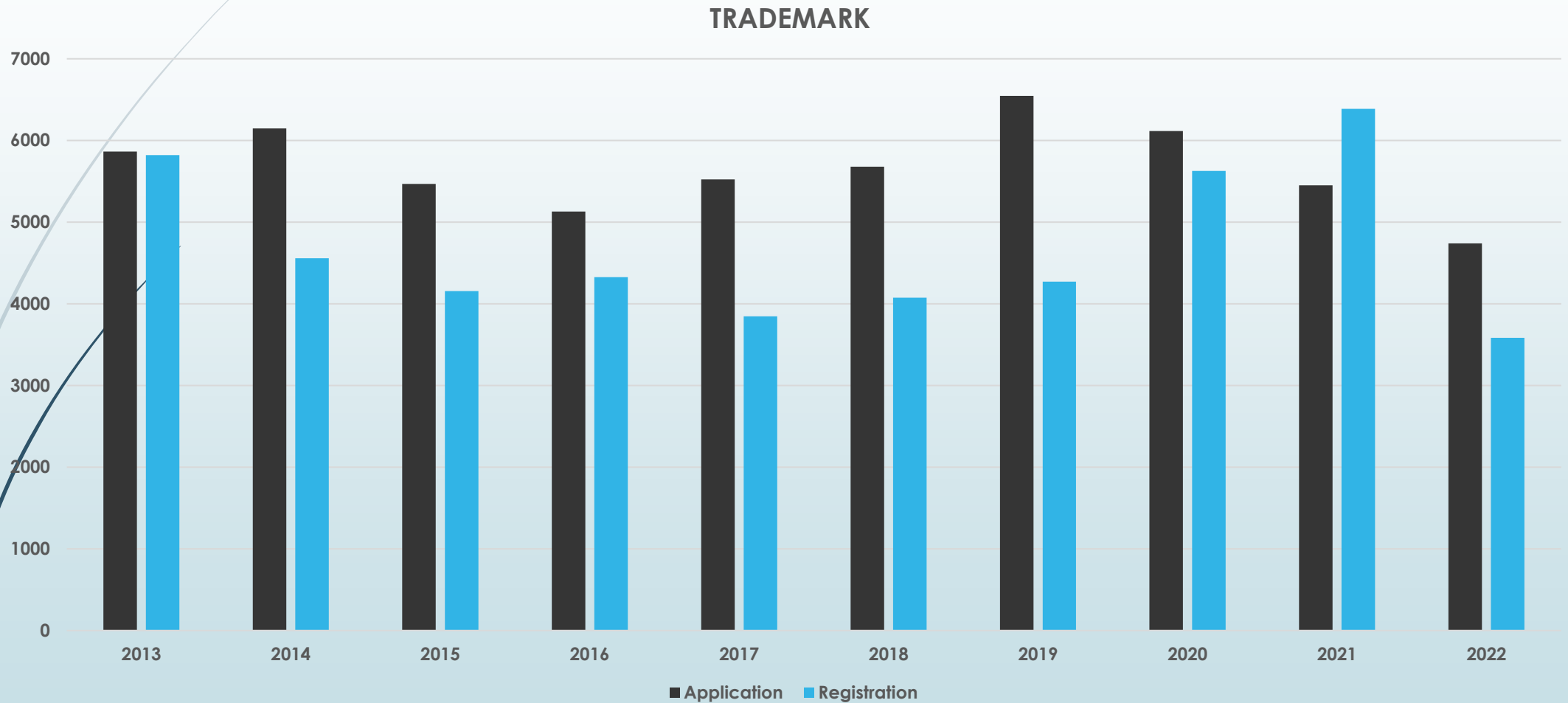

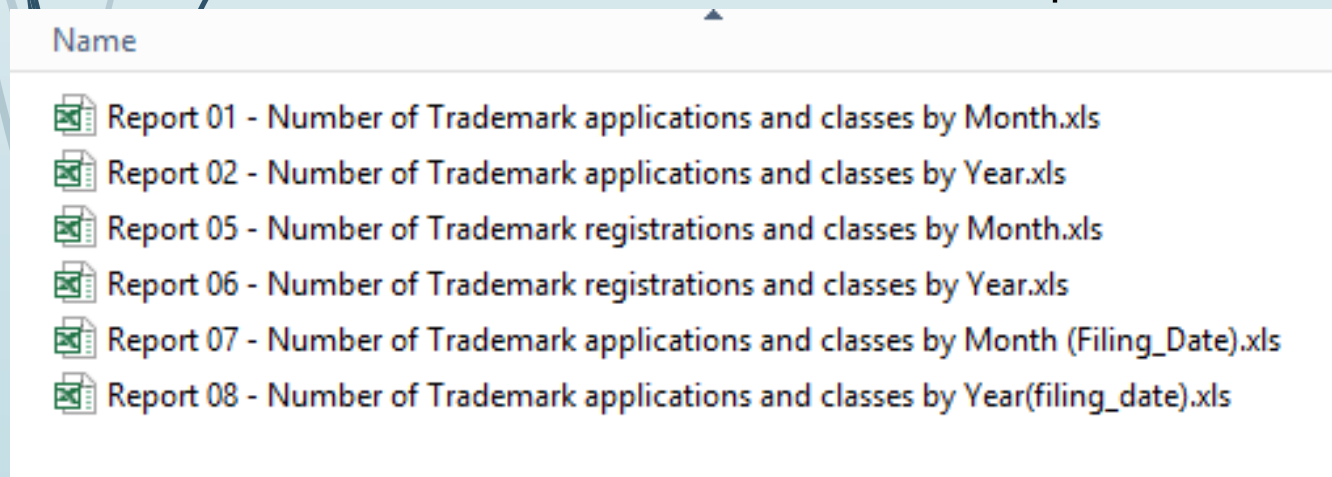

 - Run the batch file, the report will be generate in the Report folder



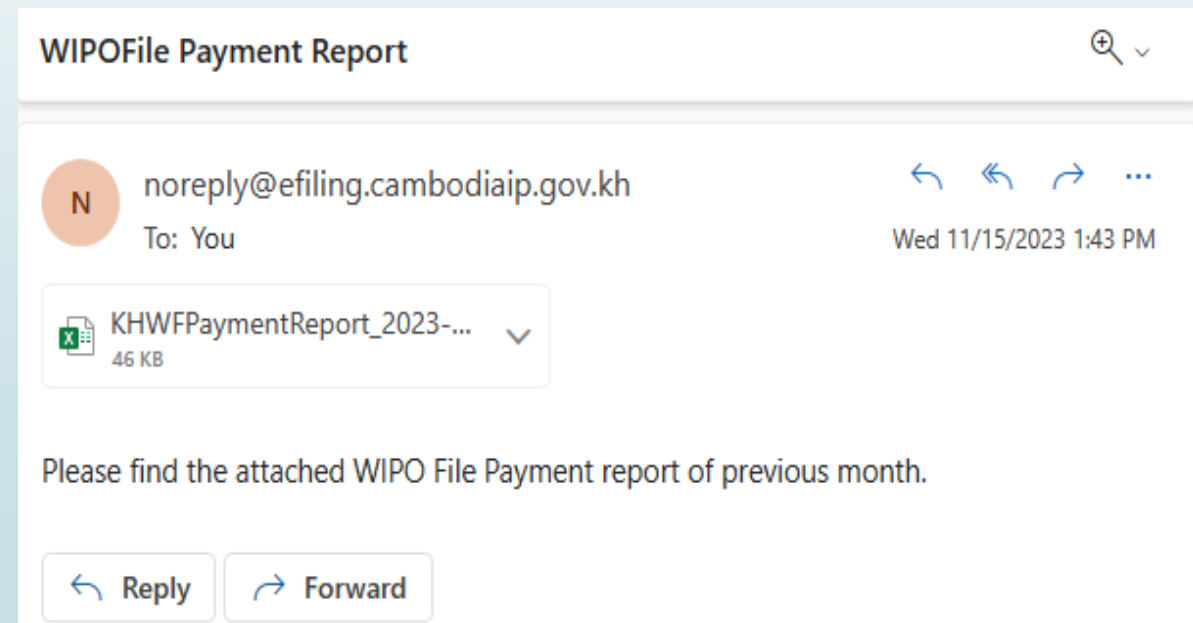
