# Publication, Data Sharing of Specification Documents

---

- **On-Premise Publication**
  - Contains both published and granted specification documents (WIPO Publish)
  - List of application and bibliographic data (e-Gazette)
- **Data Sharing of Specification Document**
  - Ongoing updates for automatic capture of data coming from EDMS to WIPO Publish
- Existing MOA for Data Exchange
  - JPO, EPO, EUIPO, KIPO

- **Description:** Digitization of BOP Appeals and Decisions Records/Files
- **Volume:** About 20,000 Pages
- **Year Range:** 1980-Present

- Development of a Hague Application Filing Portal
- Patent Certificate Upgrade (Enhancement of Security Feature)
- Conversion of ID, UM and Patent Records to XML format
- Development of a system for Searching Examination Reports (e.g. searching for similar/related findings)
- Ongoing Digitization of Admin Records (50%-70% Completed)
- Integrated system for accessing and searching Patent, BLA, and ODG cases and decisions.
