ANNUAL TECHNICAL REPORT ON

INDUSTRIAL DESIGN INFORMATION ACTIVITIES IN 1999

BY THE AUSTRIAN PATENT OFFICE

I Evolution of registration activities

The following numbers of applications/registrations of industrial designs in 1999 in Austria are presented below in comparison with the numbers in 1998 (=100%):

Number of applications:	4 941 5 363	in 1999 in 1998	(-7,9%)
Number of registrations:	4 585 5 186	in 1999 in 1998	(-11,5%)

44 % of the total number of applications in 1999 originated from applicants with residence in Austria.

The majority of the designs was applied for textiles and fabrics, components and building materials.

II <u>Matters concerning the generation, reproduction, and distribution of industrial design documents and of secondary sources of industrial design information</u>

Nothing new to report since the 1996 report.

III <u>Matters concerning classifying, reclassifying and indexing of industrial design information according to the classification system applied</u>

Nothing new to report since the 1998 report.

IV Search file establishment and upkeep

Nothing new to report since the 1997 report.

V <u>Activities in the field of computerized search systems for industrial designs</u>

An electronic registry for Appeals and Nullities including work-flow information was set up. The registry is accessible via the Intranet of the office.

Activities for securing the Y2K-Compliance of the EDP installations were carried out.

VI Administration of industrial design services available to the public

In-house access to the industrial design registry including the first image of every registered design was made available to the public.

The industrial design registry (bibliographic data) is now accessible via the Internet.

At the moment studies on the usefulness of the establishment of a similarity search procedure for industrial designs according to that for trademark similarity search are undertaken.

The pamphlets concerning the filing procedure and fees posted on the Homepage of the Austrian Patent Office were revised. All filing forms for industrial design applications were made available in pdf-format.

VIII <u>Matters concerning education and training including technical</u> assistance to developing countries

A presentation of the office's industrial design registration procedure usually forms part of the visiting and training program of the office.

On occasion of a visit of a delegation from the Intellectual Property Office of Mongolia and in cooperation with WIPO a seminar on the practices and procedures in the field of design protection was organized.

An exhibition "Designs in Austria" was presented in the entrance hall of the office in order to show both the variety of Austrian design creations and the variety of the protected design creations.
