I. Evolution of registration activities

There are 92 applications for getting titles of protection for inventions and 6 application for granting certificate for utility models were received by Kyrgyzpatent. There are 60 inventions and 9 utility models were registered in the State Register.

II. Matters concerning the generation, reproduction, distribution and use of primary and secondary sources of patent information

Kyrgyzpatent publishes the Official Gazette "Intellectualdyk Menchik" (Intellectual Property) with the official information on inventions, utility models, industrial designs, trademarks, service marks, trade names, selection achievements, computer programs and database registered in the State Registers and information about their legal status. The Official Gazette is published in Kyrgyz and Russian. Word processing was used for creation of patent information. Since 2001 Kyrgyzpatent begun to publish the 12 issues in year of the Official Gazette contained bibliographic data and claims, in 2001 was published the information for 113 inventions and 9 utility models.

Bibliographic data, claims and full description of inventions and utility models by the WIPO standards are preserved in machine-readable form and in a paper format.

In 2001 was published the systematic, numerical and owner index to the invention and utility models was published for 2000.

The Official Gazette and full description of granted patents and utility models are transferred to State Patent and Technical library of Kyrgyz Republic.

III. Matters concerning abstracting, classifying, reclassifying and indexing of technical information contained in patent documents

Abstract of patents is published on paper format in Russian. For classification of patent documents the Kyrgyzpatent uses the International Patent Classification (The Strasbourg Classification), other classification is not used.

IV. Search file establishment and upkeep

The searching of patent information into the Kyrgyzpatent database is carried out automatically on all of bibliographic data and keywords of claims.

The patent information of European Patent Organisation, Eurasian Patent Organisation, WIPO, Russian Patent Office and other countries, which contain the Patent Fund of Kyrgyz Republic in State Patent and Technical Library, are used for searching. Also for examination the search report is ordered in Russian Patent Office.

V. Activities in the field of computerised and other mechanised search systems

In 2001 the activities for development of Kyrgyzpatent local network was continued, conducting of search using Internet as well as receiving information from other sources. The web-site of Kyrgyzpatent contained full information of Kyrgyzpatent activities and legal acts of the Kyrgyz Republic in the field of intellectual property.

Equipment and software used IBM-compatible personal station of Pentium and 486 Class, Windows 95, Windows 98, Windows 2000, Fox-Pro for Windows, Windows NT, Visual Fox-Pro, Internet Explorer 4, Internet Explorer 5.

VI. Administration of industrial property office library and services available to the public

The completing of patent information fund of the State Patent and Technical Library was continued in 2001. The fund consist is patent information of national and regional patent office of several foreign countries and include the official gazettes on paper, electronic information on CD-ROM of inventions of PCT, European Patent Office, Eurasian Patent Office, Russian Federation and USPTO. Also at present on-line searching by Internet is possible.

VII. Matters concerning mutual exchange of patent documentation and information

In 2001 was continued the activities of international and regional cooperation in the exchange of patent information. Now Kyrgyzpatent exchange the patent information with various national and regional patent offices is carried out upon mutual consent.

VIII. Other relevant matters concerning education and training, and promotion of, the use of patent information, including technical assistance to developing countries

Kyrgyzpatent's specialists took active part in international seminars and training courses by intellectual property.

For public training in the field of intellectual property carry out by the Inter-institutional Department "Intellectual Property". Moreover, the specialists of Kyrgyzpatent educate the students of High Degree Institutions, Universities and Research Institutes of the Kyrgyz Republic and take certain steps for the arrangement of upgrading courses.
